

SAANICH HEAT PUMP FINANCING PROGRAM

Registration Form



The District of Saanich's Heat Pump Financing Program (the "Program"), offers interest-free financing for upgrading residential homes from a fossil-fuel based heating system to an air-to-air or air-to-water electric heat pump. Up to \$12,000 at 0% interest financing is available (including all applicable taxes). The financing will be paid as an additional payment on property taxes over a period up to 10 years.

To be eligible for financing, acceptance into the Program is required **prior to installing equipment.**

To be eligible for the program:

- The property must be located in Saanich;
- The applicant must be a registered title holder to the property;
- The home must be a single family, duplex, side-by-side townhouse or mobile home;
- The home must be primarily heated with oil, natural gas or propane; and,
- The property must be in good standing with regards to property taxes and municipal utility bills.

Step 1 Understand the Program

- Read the [Terms and Conditions](#) and the [Heat Pump Financing Service Bylaw](#).

Step 2 Register for the Home Energy Navigator

- The [Home Energy Navigator](#) is a local program that provides custom support from beginning to end in your retrofit journey. While registration is optional, we strongly recommend you sign up!

Step 3 Apply for the Program

- Complete and submit this registration form, which includes a petition for financing under section 212 of the Community Charter.
- Income-qualified participants and homes that are rented have additional documentation to submit, see details on next page.
- Once you have been accepted into the program, your petition will be certified and Council may adopt a local area service bylaw. This will secure your spot in the program, subject to steps 4-6 below.

Step 4 Carry out the pre-installation eligibility requirements

- Have an EnerGuide evaluation completed on your home.
- Get quotes from the [Eligible Contractor List](#) and select your preferred contractor;
- If you have a mortgage, [notify your lender](#) about your participation in the program and confirm it does not contravene any terms of your mortgage.
- Submit a copy of the EnerGuide Evaluation and Contractor Quote.

Step 5 Sign Financing Agreement

- Once the documents have been reviewed, you will receive a financing agreement to sign and submit.
- With the Financing Agreement in place, the program may help pay the contractor deposit.

Step 6 Carry out the Installation

- Your contractor may now remove your fossil fuel heating system and install your heat pump.
- Once the work is complete, co-sign and submit the Work Completion Report with your contractor.
- The Work Completion Report must be received within 10 months of the Local Area Service Bylaw being adopted.

Step 7 Settle the Balance

- The District of Saanich will pay your contractor directly for an amount not exceeding \$12,000 (including taxes). You must pay any outstanding balance above \$12,000 to the contractor at the time of invoice.
- Pay back the financed amount over a 10 year period on your property taxes.

Step 8 Enjoy the efficient heating and cooling of your new climate-friendly heat pump!

Income Qualified Participants

50% of spots in the program are reserved for income-qualified participants. To be eligible as an income-qualified participant, the combined income of two primary income earning adults (over the age of 18) in the family must be below the following thresholds:

Number of people in household (includes children)	Household income (before tax)
1	Up to \$55,903
2	Up to \$69,596
3	Up to \$85,560
4	Up to \$103,880
5	Up to \$117,820
6	Up to \$132,880
7 or more	Up to \$147,943

If you are an income-qualified household, we recommend you first pre-register for the CleanBC Income Qualified (IQ) Program at betterhomesbc.ca/rebates/income-qualified. The IQ Program will pay your contractor directly for the eligible rebate, and the balance is eligible for financing from Saanich.

Participants can submit proof of income from the past 18 months in one of the following ways:

- CleanBC Income Qualified Program Participant Opportunities Report; or
- Notice of Assessment for two main income earners in the family (Canada Revenue Agency).

Income Qualified Tenant:

If the home is not your principle residence, the owner OR the tenant may qualify under the income-qualified stream. If the home is participating in the income-qualified stream based on the tenant's income, the Saanich's Tenant Consent Form must be submitted to qualify.

TO ESTABLISH THE DISTRICT'S LOCAL SERVICE AREA TO PROVIDE FINANCING TO HOMES TO CONVERT FROM A FOSSIL FUEL HEATING SYSTEM TO AN ELECTRIC HEAT PUMP

I/We do hereby petition the Corporation of the District of Saanich (the "District") to establish a Local Service Area for those residential properties applying to the Heat Pump Financing Program, on the same terms as set out in the Saanich Heat Pump Financing Service Bylaw, 2022, No. 9761. This petition is brought pursuant to section 212 of the Community Charter, 2003 SBC c. 26.

1. The local area service will provide financing to residential homes that are heated by an oil, natural gas, or propane fuel source to convert to an electric heat pump (the "Service").
2. The estimated costs of the Service are the actual amount of causing the local service area's property to convert to an electric heat pump, or the amount of twelve thousand (\$12,000.00) dollars (including all applicable taxes), whichever is the lesser.
3. The proposed method of cost recovery is to be recovered by way of a parcel tax adopted under section 200 of the Community Charter, imposed only within the local service area based on a single amount for each parcel. The parcel tax shall apply to the local service area until such time as the financed amount has been completely repaid, not to exceed a term of ten years.
4. The boundaries of the proposed local service area are as follows:
