Councillor Brice and Committee members acknowledged and thanked the Director of Finance, Valla Tinney and the Director of Corporate Services, Laura Ciarniello for their commitment, support and service to this Committee. The Committee wished them both a happy retirement.

MINUTES FOR ADOPTION

1st TRIMESTER REPORT – January 1, 2022 to April 30, 2022 (attached)

The Director of Finance presented the 1st Trimester Report – January 1, 2022 to April 30, 2022 and provided responses to questions from the Committee.

Overall operational results for the period are encouraging, with most revenues reaching budgeted targets and investments exceeding budget due to higher interest rates. Expenditures are in line with expectations, however, vacancies and absences due to illness have impacted service delivery and subsequently operational expenditure.

In response to Mayor Haynes, the Director of Finance noted that staff can bring a draft policy on opportunities for interest free loans back to this committee. The policy would set out the parameters on how interest free loans can be accessed and supported.

The Committee requests that staff bring back a draft policy on interest free loans as a future agenda item.

In response to Councillor Mersereau, the Director of Finance will review the amount noted for the Urban Forest Strategy Review and Update (page 6).

For the next report, the Director of Finance will incorporate information on project start and estimated end dates under Capital Program Results.

MOVED by Mayor Haynes and seconded by Councillor Mersereau: “That the Finance and Governance Standing Committee receive the 1st Trimester Report for information.”

COVID – REVENUE IMPACT SUMMARY

The Director of Finance presented the COVID Revenue Impact Summary report dated June 30, 2022.

The report outlined the historical impact of COVID-19 on the District's revenue and conveyed current year status and future years projections for that revenue. Also noted were the current and future states of the revenues impacted by COVID19.

LONG TERM FINANCIAL PLAN RECOMMENDATIONS AND IMPLEMENTATION

The Director of Finance presented the Long Term Financial Plan Recommendations and Implementation report dated June 30, 2022.

The report summarized the recommendations from KPMG's Long Term Financial Plan Development and outlined the Finance Department's work plan for implementation.

The recommendations from the project are presented in four categories:

1. Financial Principles
 - Adopt a financial principles document to guide financial decision making.
2. Financial Policies
 - Update the Debt Management Policy to incorporate Provincial requirements.
 - Establish minimum and optimal reserve balances and update the Reserves and Surplus Policy accordingly. Schedule review of these reserve balances annually during the budget season with recommendations to increase levels sent to Council for approval.
3. Financial Plan
 - Adopt a policy which requires all master plans to contain financial projections for Council and the Finance department.
 - Quantify expenditures for all master plans and incorporate them into the Long Term Financial Plan and model.
 - Further refine mature Asset Management Plan expenditures for inclusion in the District's Long Term Financial Plan.
4. Financial Model
 - Consolidate all the capital worksheets across the organization into one financial model (to be used as a single source of truth).

MOVED by Mayor Haynes and seconded by Councillor Mersereau: "That the Finance and Governance Standing Committee recommend to Council to direct

staff to:

- 1. review and report annually on the financial principles metrics recommended in the KPMG long term financial plan, and**
- 2. prepare a draft policy on development of financial implications for major plans and strategies.”**

RECOMMENDATION

That the Committee consider both the 2023 Strategic Priorities Grants and Community Building Grants.

PURPOSE

Strategic Priorities Grants and Community Building Grants are provided to non-profit organizations, registered societies and charities seeking financial assistance. Strategic Priorities grants are intended to enhance the ability of these organizations to advance Saanich's Strategic Plan actions and objectives. Community Building Grants allow for the execution of projects or events that enhance public spaces or contribute to community vibrancy.

For 2023, there are 25 Strategic Priorities Grant funding requests totalling \$385,998 and 7 Community Building Grant requests totalling \$47,500. The total of all requests is \$433,498 which exceeds the current budget allocation of \$211,180.

Attached are the 2023 Strategic Priorities Grant and Community Building Grant applications which include each organization's most recent set of financial statements and project budget information. As well, for applicants receiving grants in the prior year a summary report on the achievement of program goals has been included.



Dear Councillor Brice,

This letter is provided to provide advice with respect to the Green Team's recent request for funding through the Saanich Community Grant.

Saanich has a policy for community grants ([COUNCIL POLICY \(saanich.ca\)](https://www.saanich.ca/EN/main/parks-recreation-community/parks/natural-areas/volunteer-for-pulling-together.html)) used to adjudicate applications. The policy states that "awards will not be provided and/or used to...duplicate an existing public or private program." Saanich Parks currently supports several community-based ecological restoration efforts directly, funded through our taxpayer's contributions.

In 2022, Parks' Pulling Together (PT) program, Park Ambassadors (PA) program, and hundreds of other community drop-in volunteers contributed a total of 16,313 hours. Saanich Parks also supported over 46 PT projects with 63 lead steward volunteers, 200 registered PT volunteers, 13 PA volunteers, and over twelve schools and community groups. As such, the work outlined in the Green Team request appears to be a duplication of an existing public service.

RECOMMENDATION

That the Committee recommend that Council approve one time funding to Goward House Society of \$10,000 from the District's COVID-19 Restart Grant.

BACKGROUND

A letter has been received from the Goward House Society requesting an additional \$10,000 in funding to assist the Society (Appendix A).

With the update to the Saanich Community Grants Program Policy Council designated six organizations as eligible for Other Community Service Provider Grants. These organizations do not need to submit annual applications for grant funding as funding levels are to be established through the development of multi-year Contribution Agreements that are approved individually by Council.

The six organizations have been provided with consistent funding since at least 2019 and as shown in the table below:

Organization	Funding Amount
Goward House Society	\$ 20,000
Haliburton Community Organic Farm Society	\$ 8,500
Horticulture Centre of the Pacific	\$130,000
Saanich Heritage Foundation	\$ 35,000
Saanich Volunteer Services Society	\$ 46,368 plus \$12,000 in kind
Silver Threads Service	\$ 59,225

The total annual amount is \$311,093 and this funding level is provided for in the draft 2023 budget.

In July of 2022, Goward House Society entered into a five-year Contribution Agreement. The District agreed to provide an annual \$20,000 Community Service Provider grant designed to assist the Society with operating expenditures.

In their correspondence, the Society indicates they have lost grant funding and operating revenue as a result of the pandemic which has impacted their financial reserves. As a result, they are projecting a deficit given the current level of funding to received.

DISCUSSION

The deficit projected by Goward House Society is due to the impact of COVID-19. The Province has provided the District with a COVID-19 Restart Grant to assist with any additional expenses or revenue shortfall that were impacted due to the pandemic. There is remaining grant funding available that the District has not utilized in 2023. Providing one time funding from this grant would help the Society with their 2023 deficit and allows them to adjust their future programming to take into account any on-going impact from the pandemic.

ALTERNATIVES

1. Recommend one time funding of \$10,000 from the COVID-19 Restart Grant
2. Recommend on-going funding of \$10,000 (additional 0.01% tax increase) and amendment to the five-year Contribution Agreement to reflect this change.
3. Do not recommend any increase to the 2023 or on-going contribution.

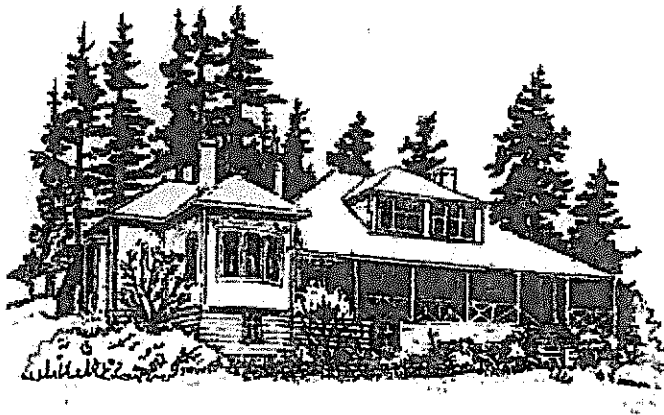

Dear Paul,

As former Senior Manager of Financial Services, I am sure you are aware the Goward House Society is a non-profit Society currently operating an activity center for citizens of the Saanich Municipality who are 55 years of age and older. Having seen our previous applications for Operating Grants, you will be familiar with the details of the programs and activities we offer at Goward House.

In July, 2022 the Society renewed and updated a five-year Facilities Use Agreement with the Saanich Municipality. At that time, the Society also entered into a five-year Contribution Agreement. Saanich agreed to provide an annual grant designed to assist the Society with operating expenses.

As the agreement was completed in July, there was no opportunity for the Society to discuss an increase in the amount of the grant for the 2022 year. The grant had already been approved earlier in the spring. The amount of the grant has not been increased for a number of years. As a result, the percentage of operating expenses covered by the grant has been reduced as expenses have increased. The grant is no longer providing its original level of support.

As with many non-profit organizations and small businesses, Goward House lost the opportunity to provide programming during the COVID pandemic. This, of course, resulted in a corresponding loss of membership and revenue. With both government assistance to retain staff and the Society's financial reserve, Goward House was able to continue operating. The Board was hoping things would improve with the lifting of COVID restrictions. Unfortunately, to date, we have not regained our pre-COVID membership numbers and corresponding revenue.

The mission of Goward House Society is to provide a vibrant activity centre combining fellowship with social, educational and special interest programs for Greater Victoria Residents aged 50 and over

The Gaming Grant Goward House has received for years was denied in 2022 due to a change in interpretation of the policy regarding charging of membership fees.

As you can imagine, for a non-profit Society, the loss of grants and operating revenue is putting a tremendous strain on the Society's financial reserves. Despite plans to generate new revenue sources, Goward House is projecting a \$30,000 deficit for the 2023 year even after receiving the \$20,000 grant from the Saanich Municipality


I had occasion to meet with Mayor Dean Murdock and CAO Brent Reems just before Christmas. During our discussions I mentioned my concern about the Goward House financial situation. Both agreed the Goward House program provides a valuable service to the community. They suggested I get in touch with you regarding an increase in the annual grant for Goward House.

It is my understanding that under the Saanich Municipality Community Grants Program, Goward House is considered for the "Other Community Service Provider Grant" along with five other organizations. These grants are not awarded on a competitive basis, but are approved by Council individually through recommendations from the Director of Finance and the Senior Manager of Financial Services. Historically, recommendations have been prepared in February for presentation to Council in early March.

To establish a context for the Society's request for an increase in the annual grant for Goward House, I have reviewed the grants awarded to the five other organizations in our category. The Goward House grant is a modest grant compared to the other grants. Considering our projected operating deficit for 2023 and the decline in the percentage of operating expenses covered by the grant, the Goward House Board of Directors would like to request, under section 9.2 of the Contribution Agreement, that our annual grant be increased from \$20,000 to \$30,000 effective May 31, 2023.

RECOMMENDATION

That the Committee recommend that Council not approve the funding request from the Community Social Planning Council for Housing Security and Rent Bank Programs.

BACKGROUND

An email was received from the Community Social Planning Council (CSPC) requesting funding for the Greater Victoria Housing Security and Rent Bank Program (Appendix A). The initial request made February 6 was for sustained financial consideration and inclusion in the District's strategic plan. A subsequent email adjusted the request to seek one-time funding from the District's 2022 surplus for this year and then subsequent sustained funding from the District's strategic and budget planning next year.

The attached request states that these two programs are "designed to help bridge households through short-term financial crises as well as advocacy and service navigation supports to help individuals identify and access any income supplement, housing subsidy, alternate housing, employment search, financial literacy or other supports they need to stay securely housed".

In order to sustain operation of the programs, CSPC is requesting an annual amount of \$90,000 (\$40,000 is for core operations and \$50,000 for project operations) from the District. CSPC is also seeking an opportunity to provide input into the District's strategic and budgeting planning process.


While CSPS has applied for other programs under the Strategic Priorities Grant, this request was made after the February 1st grant application deadline and was not intended to be under the District's community grants program.

DISCUSSION

The request from CSPC is for core operations and project support for financial assistance of household with inadequate income to meet their housing needs. Such assistance is basically social assistance. Social assistance along with health care and education are services which senior governments are mandated to provide. It has been the District's practice to not support such services financially but to advocate for them with senior governments. This is done to ensure that senior government mandated services are not download on the municipalities. This was successfully done with school playground equipment replacement.

In consultation with the Housing Division, it was noted that the request is not consistent with any of the strategic actions within the Housing Strategy. Housing staff are currently working on the Tenant Assistance Policy which will address financial support from developers for displaced renters through redevelopment or major renovation, and different from the Rent Bank Program.

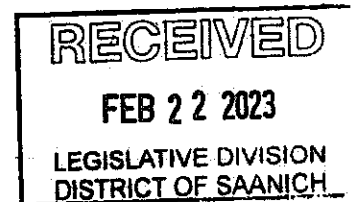

I am writing to request your consideration of sustained funding for the Greater Victoria Rent Bank. A few key points:

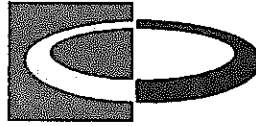

RE: Strategic Plan and Budget Consideration - Sustained Funding for Greater Victoria Housing Security and Rent Bank Program

We are requesting consideration of the Housing Security and Rent Bank Program (Program) in the city's strategic plan and budgeting process. Sustained operation of the Housing Security and Rent Bank Program is fundamental to maintaining this essential service to the community. As a core municipal partner in the Regional Housing and Prosperity (RHAP), and through the previously granted Strategic Plan Grants, the District of Saanich is a natural partner for the Program.

The Community Social Planning Council of Greater Victoria (CSPC) has been addressing the evolving needs of people experiencing poverty in the region through social planning activities and initiatives for over 80 years. We have supported sustainable community development, social enterprise, and community economic development. We have also served as an incubator for several essential organizations in the region, including the United Way of Southern Vancouver Island, Volunteer Victoria, and Bridges for Women. The CSPC has a long history of supporting social well-being across the region, and through strong community engagement and support, it launched the successful pilot phase of the Greater Victoria Housing Security and Rent Bank Program (Program) in 2021 to fill the gap that low-income individuals and families experiencing a short-term financial crisis need to improve their housing security amidst the Covid-19 pandemic.

We would like to explore a deeper synergy between the CSPC and the District of Saanich through enhanced partnership and sustained funding for the Program. To ensure the viable continuation of the services the Program provides to the city's most vulnerable, the CSPC needs longer term commitments for core annual budgets in the form of multi-year support. We are also reaching out to all the municipalities in the region for their support.

The program is delivered by a team of experienced social workers who work with households at risk of eviction across the region. The case workers help the households to stay stably housed by intervening with landlord, providing financial literacy support, helping them to navigate the other income assistance and service that may be available to them. Where appropriate they are provided with financial assistance from our program. In the past year approximately 2064 households were provided with casework supports of which 258 households were given financial assistance. On average, **21% of the households using the Rent Bank are from the District of Saanich.**

The Need

Our work on the Point in Time Homeless Count reveals that many individuals experiencing homelessness in the region are there because of a short-term financial or health crisis.¹ The Housing Security Program and Rent Bank Program is designed to help bridge those households through a short-term financial crisis, not just with financial assistance but with advocacy and service navigation supports to help them identify and access any income supplement, housing subsidy, alternate housing, employment search, financial literacy or other supports they need to stay securely housed. With the increases in the cost of living and housing in the region, more and more households are operating without the financial means to weather a short-term crisis. **A recent Statistics Canada report found that 1 in 4 households in Canada would be unable to cover an unexpected expense of \$500.** That is one car repair, one emergency trip for a family crisis, one lost paycheck for illness. Housing costs in the region are a big factor putting households at risk. **On average, the households in the program are spending over 60% of their income on housing.**

The majority of households accessing the Rent Bank are not already connected to services. They often reach out for help through the 211 call line. Though they are not always eligible for Rent Bank funding, the case workers will help any household that reaches out to find programs and supports they need to avoid eviction.

This program is preventing homelessness for individuals that would otherwise be at risk. A recent evaluation shows that this program has been successful in preventing eviction in most cases. A significant majority of participants (89%) said the intervention stabilized their housing and a similar proportion (87%) said they likely would have become homeless without the support.² The sustained operation of the Program is fundamental to maintaining this essential service to the community.

Saanich's contribution is key to leveraging other funding. Funding for the program comes partially from the provincial government but they require matching funding, ideally from other levels of government. Thus, Saanich's contribution will be key to leveraging the provincial funding for the regional Rent Bank. Further, Saanich as a lead partner in supporting this program has helped to bring other municipalities to the table on funding. The City of Victoria and Colwood were the only two partners that committed to funding in 2022. Langford, and Oak Bay are now considering funding as well. Thus, Saanich's contribution will continue to be instrumental in bringing other municipalities to the table.

There is a clear and present rationale for continued and enhanced partnership between CSPC and the District of Saanich on this Program. This Program supports the District's Strategic Plan objectives to advance the Saanich goal of Community Well-being, particularly its mandate to ensure all residents, including those experiencing homelessness, are represented in the municipality's solutions or decisions. It supports the BC Government's legislated responsibilities on poverty reduction and the efforts to prioritize housing and address/prevent homelessness. It is also aligned with the transformative goals #1, #10, and #11 of the Sustainable Development Goals (SDGs).

Total request from the District of Saanich is \$90,000 annually (\$40,000 for core operations and \$50,000 for project operations). We would be happy to meet and discuss further to help ensure consideration of

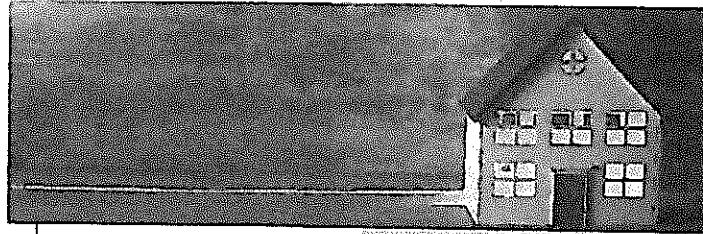

The Rent Bank provides financial assistance in the form of a no-interest repayable loan to households at risk of eviction for reasons such as non-payment of rent or essential utilities. The loan can also be used as a damage deposit and/or first month's rent to move to safe and sustainable housing.

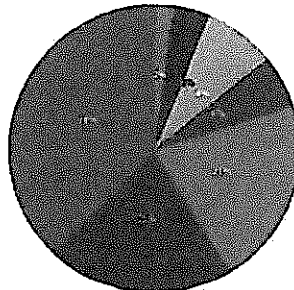

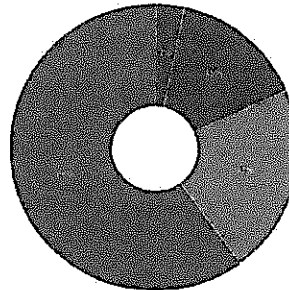

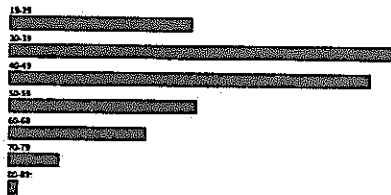


GENDER
