### **QUALIFICATIONS FOR OFFICE:**

A person is qualified to be nominated, elected, and to hold office as a member of local government or as a School Trustee if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting date (Saturday, October 15, 2022);
- Resident of British Columbia for at least six months immediately preceding the day nomination papers are filed; and
- Not disqualified under the Local Government Act or any other enactment from being nominated for, being elected to or holding office, or to be otherwise disqualified by law.
- A person or the commander of an armed forces unit who has been granted freedom of the municipality, if that person is a Canadian citizen (for Municipal Council offices only).

### **CAMPAIGN PERIOD EXPENSE LIMITS:**
