Memo of the November 4, 2019 Mayor's Standing Committee on Housing Affordability and Supply recommending that Council send letters to the University of Victoria and Camosun College to encourage them to look at additional on-campus housing.

MOVED by Councillor Mersereau and Seconded by Councillor de Vries: "That the Mayor write on behalf of Council to invite the University of Victoria and Camosun College to a meeting of the Mayor's Standing Committee on Housing Supply and Affordability to discuss additional oncampus housing and options to encourage good conduct among students living off-campus."

Council discussion ensued with the following comments:

- A formal step in starting discussions for housing options.
- Handbooks and policies that address conduct in the broader community should broach with UVic and Camosun.
- There are many communities that have universities that have a shared responsibility.
- Want a different relationship that currently exists.
- UVic and Camosun need to step up.
- They need to understand the impact to the municipality.
- It might be appropriate to invite UVic and Camosun to present to Council.

MOVED by Councillor Plant and Seconded by Councillor Mersereau: "That the motion be amended to read: "That Council invite the University of Victoria and Camosun to a future Committee of the Whole meeting."
