# BACKGROUND

Recently Premier Horgan spoke highly of the film industry in British Columbia, and that the Province was open for the movie business. At the same time Federal Minister, the Honourable Catherine McKenna, was quoted saying: "Ottawa seeks 'shovel-ready' projects for a post shutdown stimulus plan." Together, these two statements offer timely synergy for projects to bring movie studios to Saanich and elsewhere on the peninsula that have been developing over the last two years. Previously, Council sent a letter to the Honourable Melanie Mark, Minister of Advanced Education, Skills, and Training, referencing their support for film studios in the Capital Regional District (attached).

This project is being led by representatives of educational groups, the Victoria Film Commission, local industry professionals and interested local developers. The project includes the construction of three film studios of 18,000 square feet, production office space, and classrooms. From the leadership groups, I understand the project is seeking both Provincial and Federal support. With the financial assistance of the Federal Government, construction could begin almost immediately. The benefits to the economy of the South Island would be enormous.

Typically a production filming in an 18,000 square foot studio would employ over 200 people. A complex with three studios would provide more than 600 new jobs, and bring an immense amount of ancillary spending in the community. As all studios in Vancouver are at full occupancy, there is considerable market confidence that these facilities would be pre-booked immediately on commencing construction. Keith Woods, President of IATSE Local 891, has written a letter in support of this proposal (not attached).

The use of Federal and Provincial funds to develop infrastructure for the film industry in British Columbia is not without precedent. The first studio complex in Vancouver, Bridge Studios, originally occupied Crown land. The film industry now produces \$3.4B in annual revenue in this province. The estimated total budget for construction of this project is \$24M. With \$10M of financial assistance on the Federal level, this project could proceed immediately as a successful public-private partnership.

This report is to raise Council's awareness of the opportunity and request their support for a letter to draw this unique opportunity to the attention of the Honourable Minister Joyce Murray, the office of Western Economic Diversification Canada, and the Premier of British Columbia in order to garner Federal and Provincial financial support for the project. As noted, this project will be of

immense benefit to the resurgent film industry post COVID-19, and the economy of Southern Vancouver Island in general.

#### RECOMMENDATION

That Council write a letter of support regarding the economic and cultural benefits movie studios would bring to the region to the Honourable Minister Joyce Murray, the office of Western Economic Diversification Canada, the Finance Minister of British Columbia, and the Premier of British Columbia, and requests they consider applications from projects seeking financial support.

 Police statistics show that 85% of drivers operate at safe levels but 15% do not.

In response to questions from Council, the Director of Engineering stated:

- Staff will make contact with other municipal engineering departments in the region to discuss the educational, enforcement and infrastructure issues.
- Potentially could be a joint application dependent on the municipal response.
- Work will take place in the spring of 2020.
- First phase, which closed this week, is to look at e-devices being allowed on local streets and cycle tracks, such as scooters.
- Second phase of the pilot project for the fall of 2020, is to lower default speed limits.
- The CRD does not have jurisdiction over our roads.

Council discussion ensued with the following comments:

- Apprehensive in the enforceability. Education is important but the tools to enforce the speed limits are also important.
- Evidence suggests that vehicles traveling at 30 km/h reduce the likeliness of collision and death or injury.

In response to a question from Council, the Director of Engineering stated:

 Will consider involving ICBC and the CRD Traffic committee in discussions about educating the public.

#### LETTER OF SUPPORT - FILM STUDIO IN THE CRD.

Letter of support from Mayor Haynes for a film studio to be built in the Capital Regional District (CRD) to be forwarded, as an endorsement to the Honourable Melanie Mark, the Minister of Advanced Education.

Council discussion ensued with the following comments:

- More public engagement needs to be done.
- The letter of support is also linked to an educational package to allow more training of people in the movie industry.
- Consistent with what Council has signaled it would like to encourage.
