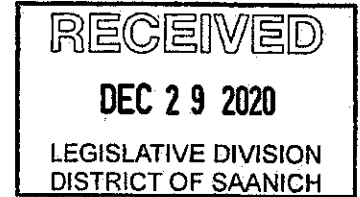

RECOMMENDATION

That Council receive this report and take the described action to forward the recommendations made within the Saanich Peninsula Child Care Inventory and Action Plan.

PURPOSE

The purpose of this report is to provide Council with information gathered from the community during the consultative process that resulted in the Saanich Child Care Inventory and Action Plan. Specifically, the information contained within "Section IV. Advocacy", makes recommendations that cannot be addressed by municipal governments, but rather require action by other orders of government.

BACKGROUND

In a report from the Director of Parks, Recreation and Community Services dated September 16, 2020, Council received for information the Saanich Peninsula Child Care Inventory and Action Plan. Upon hearing the presentation by staff and consultants, Council made the following motions:

MOVED by Councillor Chambers and Seconded by Councillor Brice: "That Council receive for information the Saanich Peninsula Child Care Inventory and Action Plan and forward it to the Strategic Planning process for consideration."

The Motion was then Put and CARRIED

MOVED by Councillor Plant and Seconded by Councillor Chambers: "That Council direct staff to bring forward a report on the potential to advance the advocacy items outlined in the consultant's report."

DISCUSSION

District of Saanich Child Care Inventory and Action Plan - Section IV. Advocacy (p. 52)
Identify ways to leverage additional support by writing letters and calling upon other orders of government to take action.

There are a number of advocacy items identified in the Child Care Inventory and Action Plan. While some can be achieved by virtue of a letter, others will take more time and actions by other. Some of the items may have unintended consequences and require further exploration and discussion by Council.

Based on the above, staff have evaluated the advocacy recommendations and provided Council with the following recommended actions:

STRATEGIC IMPLICATIONS

FINANCIAL IMPLICATONS

Many of the recommendations in the District of Saanich Child Care Inventory and Action Plan only require staff time to draft a formal letter, and the consideration and endorsement from Saanich Council.

Other items are more complex and could have secondary planning or financial effects. Those items have been referred for more robust consideration during Council Strategic Planning process.

CONCLUSIONS


The Child Care Inventory and Action Plan contains many progressive, systemic recommendations that remove barriers and support the creation of new child care spaces and support already existing businesses.

Increasing the inventory of child care spaces available to working families certainly has a positive impact on the livability of this community. However, altering the structures that govern child care facilities has the potential to cause secondary impacts to neighbourhoods and businesses alike. Council must carefully consider all angles, and call upon subject matter experts, before choosing a direction on new space development for Saanich.

Write a letter encouraging the Ministry of Children and Family Development Child Care Capital Program to make it easier for organizations seeking to apply for Child Care New Spaces Funds by publicly sharing designs of child care facilities incorporated into various setting, such as modular buildings and child care incorporated into office spaces.

21. Write a letter to the Ministry of Children and Family Development, copying the BC Early Childhood Registry, encouraging them to improve the numbers of people who progress from their ECE Assistant certificate to becoming ECEs by creating a time limit on the numbers of years an individual can be certified as an ECE Assistant.

22. Write a letter to the Ministry of Children and Family Development, supporting a revision to the BC Child Care Regulations, including:

- Implementing the Child Care Resource and Referral Centre proposal that registered license-not-required facilities be allowed to care for three children or a sibling group, in order to provide a stronger incentive for facilities to register, thereby creating greater oversight and support for child care providers; and
- Updating the language in the Child Care Licensing Regulations to describe children with extra support needs, and in the interim, work with the ECE Registry and ECE training providers to update the terms used in their certificate programs, to remove the term "special needs".

Ministry of Citizen's Services

23. Write a letter to the Ministry of Citizen's Services, encouraging the Government of BC to lead by example, and incorporate child care facilities into as many of their publicly owned buildings as possible.

Ministry of Health

24. Write a letter to the Ministry of Health encouraging the creation of a pilot for licensed outdoor based child care programs.

25. Write a letter to the Ministry of Health, copying Island Health and the Ministry of Children and Family Development asking them to:

- Publish an annual report for each regional district across BC, with the ratio of licensed child care spaces to numbers of children 0-2 years old; and
- Resolve the data discrepancies between the BC Child Care Map maintained by the Ministry of Children and Development and the inventory of licensed child care spaces maintained by the Health Authorities.

South Island Prosperity Partnership

26. Present child care inventory and action plan findings to the South Island Prosperity Partnership, and write a letter asking them to consider including an annual indicator on the ration of licensed child care spaces per child 0-2 years old, using data from Island Health Child Care Licensing.

Submit a resolution to the UBCM stating that:</p> <p>WHEREAS the Supported Child Development community-based program funded by the Ministry of Children and Development provides extremely valuable assistance for families of children with extra support needs to access inclusive child care;</p> <p>AND WHEREAS the funding for this program is inadequate to meet family needs resulting in years-long waitlists;</p> <p>THEREFORE BE IT RESOLVED that UBCM lobby the Provincial Government to increase the Supported Child Development funding."</p>
