Dear Premier:

Re: Ban of Anticoagulant Rodenticides

Saanich Council formally requests the Province to ban the use of anticoagulant rodenticides throughout British Columbia. It has been well-documented for over a decade that anticoagulant rodenticide (rat poison) products poison non-target wildlife in large numbers. Examples include owls, hawks, small birds, earthworms, coyotes and even cougars. They also pose a risk for pets and children to be poisoned.

Saanich Council at their meeting of July 13, 2020 resolved as follows:

"That Council:

- 1. Provide direction to staff to implement a ban of anticoagulant rodenticides on all District of Saanich properties and in all District of Saanich facilities and lands;
- 2. Request that the Mayor write, on behalf of Council, to the Premier of British Columbia, appropriate Ministers, copying Members of the Legislative Assembly in the Capital Region, requesting that the Province of British Columbia ban anticoagulant rodenticides;
- 3. Direct staff to communicate to residents and businesses in the District of Saanich, Council's direction on this matter, the harmful impacts of anticoagulant rodenticides, and better alternatives that are available; and
- 4. Share this report with all other local governments."

Dear Mayor Haynes and Council:

Thank you for your letter of July 22, 2020, which was also addressed to my colleague, the Honourable Doug Donaldson, Minister of Forests, Lands, Natural Resource Operations and Rural Development, regarding a ban on rodenticides. As the topic you raised falls under my ministry, I am pleased to respond on behalf of my colleague.

Rat infestations can pose a risk to human health and the environment, and rodenticides are one tool that may be considered as part of an integrated pest management (IPM) process to manage rodent pests. Anticoagulant rodenticides, typically applied as bait in enclosed tamper-resistant stations, function by inhibiting blood clotting once ingested by rodents. If other animals then consume the poisoned rats, there is a risk of secondary poisoning.

Pesticides, including rodenticides, can only be used in Canada if they have been evaluated and registered by Health Canada's Pest Management Regulatory Agency (PMRA). PMRA's scientists conduct stringent risk assessments to prevent unacceptable risk to human health or the environment from pesticides. Registered pesticides are then re-evaluated every 15 years to factor in any new information and adhere to modern safety standards.

After PMRA's last re-evaluation of several anticoagulant rodenticides, Health Canada imposed new label restrictions and risk mitigation measures to, in part, reduce risk to non-target wildlife species. Commercial anticoagulant rodenticides may now only be used by farmers, certified pesticide applicators, or persons authorized in government-approved pest control programs.

Under the B.C. *Integrated Pest Management Act*, the Ministry of Environment and Climate Change Strategy sets standards over and above federal label requirements for human health and environmental protection from pesticides. The use of most rodenticides on public land requires a licence and a certified applicator, and IPM principles must be used to guide pest management decisions, consider pesticide alternatives and prevent any non-essential pesticide use. My ministry also provides outreach material for rodent IPM on its website. Steps are described for prevention, rodent-proofing structures, and the use of physical control methods such as traps, with the use of anticoagulant rodenticides considered only as a last resort.

Staff in my ministry are closely monitoring the impacts of rodenticide use and are engaging with Health Canada on the matter. Staff recently increased compliance activities and provided additional guidance to vendors and to structural pest control operators. If further action is needed, additional training or guidance material may be developed, more targeted compliance and enforcement may be conducted, or regulatory changes may be considered to further minimize risk; however, a provincial ban is not being considered at this time, despite our ongoing review.
