SIDEWALK INFRASTRUCTURE DEVELOPMENT IN SAANICH

Recommendation from the March 6, 2014 Finance, Audit and Personnel Standing Committee that the report of the Director of Engineering dated February 19, 2014 be forwarded to a Financial Plan meeting with a recommendation that staff be directed to bring forward information to a future Council meeting with respect to potential amendments to the Subdivision Bylaw; and report of the Director of Engineering dated April 2, 2014 recommending staff continue to use the existing policies and planning tools to prioritize new sidewalk capital projects (Pedestrian Priorities Implementation Plan, in conjunction with the direction contained in the Official Community Plan and Local Area Plans); and that staff revise the current engineering standards to allow for the construction of sidewalks on certain residential streets in Regional Growth Centres.

In response to questions from Council, the Director of Engineering stated:

- Changes to engineering standards may allow for construction of sidewalks on certain residential streets within Regional Growth Centres.
- Amendments to the Subdivision Bylaw could require that funding be provided for sidewalks when development is proposed within Regional Growth Centres.
- A key component of the Complete Streets program includes providing safe and comfortable walking and resting areas.
- The challenge of having the public donate money for benches is that they want them in park areas, not along residential streets.

MOVED by Councillor Brownoff and Seconded by Councillor Brice: "That Council:

- 1. Direct staff to:
 - a. Continue to use the existing policies and planning tools to prioritize new sidewalk capital projects (Pedestrian Priorities Implementation Plan, in conjunction with the direction contained in the Official Community Plan and Local Area Plans); and
 - b. Revise the current engineering standards to allow for the construction of sidewalks and resting areas on certain residential streets in Regional Growth Centres; and
- 2. Provide direction to staff that the number of kilometres of new sidewalks be increased to three kilometres in the 2015-2019 Strategic Plan."
