In response to guestions from Council, the Director of Finance stated:

- It is not recommended to use surplus funds to lower the tax rate.
- Surplus funds are generally used for one-time purchases; reducing tax rates using surplus funds is funding an ongoing expenditure.
- Saanich does have a balanced budget but generally does end up with a surplus due to vacancies or cost savings; the annual surplus from 2014 not allocated through one-time resource requests is approximately \$200,000.

- C. The Municipality will continue to support local organizations through permissive tax exemptions. The objective is to consider exemptions individually on their merits, in context with the Saanich Strategic Plan."
