- Pricing based on annual fees and charges approved for Saanich Parks.
- Saanich Parks reserves the right to make the final decision on donation location.
- Saanich Parks will approve and finalize and plaque wording.
- Saanich Parks will maintain the donation and repair damage.
- Saanich Parks has the right to move the item to a different location due to operational needs and/or any future unforeseen events.
- I understand that the item will remain for 10 years, at which time I will be offered the opportunity to renew the item for an additional 10 years, at the cost posted in that renewal year.
- I will provide any new contact information (phone, email, address) for myself or any alternate contacts during the donation term, to ensure that I can be contacted in 10 years' time.
- I understand that should I, or any named alternate contact, not respond to communication attempts to renew in 10 years' time, the donated item will be made available to new donors and any plaque acknowledging my donation removed.
