Active Transportation Plan Report Card 2023

We have met or exceeded the targets in 11 of the 24 measures of success outlined in the 2018 ATP. We have improved accessibility and weather protection at our bus stops and we continue to work with BC Transit to prioritize transit travel times and reliability, which are proven to encourage more people to ride the bus. In 2023 we completed an update to the ATP and we increased the number of kilometres of protected on-street and off-street AAA facilities.

We have aggressive road safety targets, and more effort is needed to reduce the number of collisions involving pedestrians and cyclists. The upcoming Road Safety Action Plan will guide future investments and changes that will improve safety for all road users. Expanding and upgrading bike routes on residential streets will be an area to focus on going forward to ensure Saanich is on track with its mode share and infrastructure targets. Sidewalk construction continues to get more costly and achieving success in expanding the network will require investment and creativity.
