Job Purpose

Supervises and participates in the work of a crew carrying out installation, rehabilitation, repair, inspection and testing of Water, Wastewater, and Storm Water systems.

Duties and Responsibilities

- Plans, assigns, directs, and inspects the work of employees engaged in one or more of the following: water mains, sewer and drain or construction and maintenance.
- Performs any combination of tasks pertinent to installation and control of the operation of a water distribution or wastewater collection system.
- Ensures the safety of work crews and the public by enforcing all appropriate municipal and W.C.B. safety regulations.
- Conducts daily construction and site safety meetings.
- Inspects worksites regularly for efficient and safe work practices and procedures.
- Requisitions materials and equipment required for jobs undertaken.
- Participates in pre-planning sessions for projects.
- Assists with preparation of cost estimates for planned and future work and projects.
- Responds to and investigates complaints from the public and takes corrective action.
- Trains and instructs others in the proper, safe methods of work.
- Prepares employee performance appraisals for supervisor's review.
- Records and maintains a variety of data and information to track operations, and prepares reports, using paper and electronic formats.
- Makes recommendations on technical matters with supervisor and operators to optimize treatment efficiency to meet all water or wastewater regulatory standards.
- · Responds to emergency calls for service.
- Performs other related duties as required.

Storm and Wastewater

 Works in and around creeks/waterways, and understands environmental protocols and best management practices.

Waterworks

 Works on the potable water system understands and follows best management practices to maintain water quality.

Qualifications

- Grade 12 or equivalent.
- EOCP Level II Certification for Wastewater Collection or Water Distribution.
- Four years of pipefitting experience in water or wastewater systems including experience in project management and two years of experience in a supervisory capacity directly related to maintenance

and/or construction work, specific to the Water or Wastewater Section.

- Supervisory skills training.
- Proficiency in field based GIS software.
- Spill Response Training as required.
- An equivalent combination of education and experience may be considered.
- Valid Class 5 BC Driver's Licence.
- Completion of technical training/courses related to water, wastewater and system maintenance and construction, estimating and project management.
