NOTICE IS HEREBY GIVEN that a SPECIAL COUNCIL MEETING for the purpose of a PUBLIC HEARING will be held in the SAANICH MUNICIPAL HALL COUNCIL CHAMBERS, 770 Vernon Avenue, Victoria, BC, V8X 2W7, on **TUESDAY**, **JUNE 18, 2024, at 7:00 P.M.**, to allow the public to make verbal or written representation to Council with respect to the following proposed bylaw amendments.

#### A. HERITAGE DESIGNATION BYLAW (2254 ARBUTUS ROAD), 2024, NO. 10011 HERITAGE DESIGNATION APPLICATION ON ARBUTUS ROAD

The intent of the proposed bylaw is to designate the Jupp Residence dwelling at Lot 11, Section 45, Victoria District, Plan 1045 (**2254 ARBUTUS ROAD**) as a municipal heritage building.

#### B. OFFICIAL COMMUNITY PLAN BYLAW, 2023, AMENDMENT BYLAW, NO. 10032 PROPOSED AMENDMENTS TO THE DEVELOPMENT PERMIT AREA GUIDELINES

The intent of this proposed Official Community Plan Bylaw Amendment is to amend Schedule "B": Development Permit Area Guidelines to remove the development permit requirement for garden suites; to exempt development resulting in four or fewer dwelling units on a parcel from the Form and Character development permit requirement; replace Section 4 Houseplex Guidelines with a revised set of design guidelines for houseplexes to align with the Provincial legislation; and to replace plates 32, 40 and 44 of the Streamside Development Permit Area as a result of new data provided by Qualified Environmental Professionals on behalf of the owners of the subject properties.
